In accordance with following university's decree and rules:

- Academic senate resolution on 12.05.2025 and Administrative board resolution on 15.05.2025 about the approval for the academic year 2025-26 of the Master's Program -International Master of Cardiology and Techniques Applied to Cardiac Surgery
- The Rectoral decree Rep. N. 739 Prot. N. 231315/III/5 del 24.10.2025 for the activation for the academic year 2025-26 of the Master's Program - International Master of Cardiology and Techniques Applied to Cardiac Surgery

#### Whereas:

- the resolution of the DIGIP Department council on 18.05.2025, which approved the financing of 6 grants of € 9.900,00 each within the ANTHEM project, to support research activities within the participation to Master's Program International Master of Cardiology and Techniques Applied to Cardiac Surgery for the academic year 2025-26;
- The resolution of the Conuncil of the SdM Scuola of Alta Formazione on 20.09.2025 that allowed to start the issue of the grant;

### **ISSUES**

# ART. 1TOPIC

6 Grant available of 9.900,00 € each, gross value of taxes due to by the successful tenderer, involving the participation to Master's Program - International Master of Cardiology and Techniques Applied to Cardiac Surgery" for the academic year 2025-26. Successful tenderer will also be exempted by payment of the Master enrolment fee. Grants will be split into 9 monthly payments.

#### **ART. 2 DUTIES**

Successful tenders have to enrol in the master program, follow the courses and all the activities included in the master program. Individual traineeships and all other individual training activities part of the master program will be functional to Anthem research program, hosted by the institution reported in the next table. The Commission will be responsible for associating each successful tenders with Topic and institution

### **ART. 3 PARTICIPATION REQUIREMENTS**

Applicants can submit their application, within the deadline, if they meet all the following requirements

- Having completed the pre-enrolment process to the master Program- International Master of Cardiology and Techniques Applied to Cardiac Surgery by 11<sup>th</sup> November 2025
- Own one of the following degrees:
  - LM-41 Master's degree in Medicine and Surgery obtained in accordance with Ministerial Decree No. 270 of 2004; or equivalent Degree in Medicine obtained under previous regulations;
  - Equivalent Degree obtained abroad, recognized as eligible according to current regulations.

Requirements must be held by the candidate by the deadline date of this application call.

### ART. 4 APPLICATION AND SUBMISSION

Candidates can submit their application using attached template (Attachment 1). Application must be submitted, with all required certificates and documents, by 11<sup>th</sup> November 2025 **at 12.00.** All application received after the aforementioned deadline will be automatically excluded and not considered.

The application, drafted on plain paper according to the attached template (Attachment 1), dated and signed, must include the following attachments:

- Copy of a valid identity card/passport
- Curriculum vitae in European format
- master enrolment form with the documentation required by the announcement published on the course page https://sdm.unibg.it/corso/cardiology/

The application must be sent:

Both the template and the attachments must be signed and scanned accompanied with copy of ID card of the candidate, or sent by pdf if digitally signed (digitally certificated sign) If application is sent by electronic certificated mail (pec) please consider that system generates automatic receipt if attachment are less then 30 Mbyte and overall the mail with the application cannot exceed 45 Mbyte. Automatic receipt generated by system represents the formal date and hour of submission.









Neither the Application or attachment sent after the deadline will not be considered in the evaluation process.

### **ART. 5 EVALUATION COMMITTEE**

The Committee will be designed after the deadline of this call for application by the director of the SdM. Commission will hold the evaluation process of the application received.

The Committee can manage the evaluation procedures remotely, respecting privacy and traceability of the communications

#### **ART. 6 EVALUATION CRITERIA**

The commission evaluates the applications received based on qualifications and interview for a maximum overall score of 50 points as indicated below:

### **QUALIFICATIONS EVALUABLE up to a maximum of 30 points:**

- 1) Additional qualifications further than the degree required at Art.3 and related to topic of the master program (up to 7 points)
- 2) English language certification (up to 3 points)
- 3) Professional experiences related Cardiac Surgery, Cardiology, Cardiac Anaesthesiology (up to 10 points)
- 4) Professional or educational activities related to Cardiac Surgery, Cardiology, Cardiac Anaesthesiology gained abroad (up to 7 points)
- 5) Curriculum (up to 3 points) It will include the evaluation of any other aspect reported in the Cv excluding those already evaluated in the previous criteria

Qualifications declared must be held by the deadline of the application call. Qualifications must be declared based on art. 46 e 47 del DPR 445/2000, attached to the application (pdf) where not self-declared.

### Interview (up to 20 points)

Oral exam will be in English and it will be related to understanding the competencies and experiences already developed on one of the following topic: Cardiac surgery, Cardiology, Cardiac anaesthesiology.

Candidates will be summoned for the oral exams that will be handled remotely by using Google meet **in a day and time communicated afterwards by an announcement published** on the University Web site at the following link <a href="https://sdm.unibg.it/corso/cardiology/">https://sdm.unibg.it/corso/cardiology/</a>

Candidates must use suitable connection and using device with microphone and camera.

In case of equal score the grant will be given to the younger candidate. In case of waiver by a candidate, the ranking list will be reviewed, and the next eligible candidate will be considered for the grant .

# **ART.7 INCOMPATIBILITY**









It is not possible to benefit from the grant if the applicant is already the recipient of other research grants or fellowships.
